

ORDINANCE NO. 2015-27

AN AMENDMENT TO ORDINANCE NO. 2014-53 ESTABLISHING A SCHEDULE OF FEES TO BE CHARGED FOR VARIOUS RECREATIONAL ACTIVITIES AND RENTALS AND PAYMENT SCALE FOR SCOREKEEPERS AND OFFICIALS FOR THE RECREATION DEPARTMENT FOR THE FISCAL YEAR 2015; AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Council of the City of Clyde, State of Ohio:

SECTION 1. That Section 1 of Ordinance No. 2014-53 passed by Clyde City Council on November 18, 2014 which presently reads:
