

CLYDE CITY COUNCIL
Special Session - Reorganization of Council
January 5, 2016

Clyde City Council held a special session at 6:30 p.m. on January 5, 2016 in Council Chambers of the Municipal Building, 222 N. Main Street, Clyde, Ohio for the sole purpose of holding the reorganization meeting.

City Solicitor Zachary Selvey called the meeting to order.

Mr. Selvey conducted the swearing in of new Council Members Jean Jackson and Gary Smith.

SETTING SALARIES OF COUNCIL

Mr. Selvey stated that the current salaries are at the current amount allowed by the Charter.

Motion: to keep Council salaries the same as 2015 and consistent with the City Charter for the year 2016, **Action:** Approve,

Vote: Motion carried by unanimous roll call vote (**summary:** Yes = 5).

SETTING SALARY OF MAYOR

Mr. Selvey stated that this salary is also set by a Charter provision.

Motion: to keep the Mayor's annual salary the same as 2015 and consistent with the City Charter at \$4,000 for the year 2016, which is in addition to the Council salary that the Mayor receives,

Action: Approve,

Moved by Council Member – Ken Dick, **Seconded by** Council Member – Steve Keegan.

Vote: Motion carried by unanimous roll call vote (**summary:** Yes = 5).

The Vice Mayor's salary is set by Ordinance. No vote is necessary.

ELECTION OF MAYOR

Mr. Selvey opened the floor for nominations for Mayor.

Motion: to nominate Scott Black for Mayor for the year 2016, **Action:** Approve, **Moved by** Council Member - Kenneth Dick, **Seconded by** Council Member - Steve Keegan. **Vote:** Motion carried by unanimous roll call vote (**summary:** Yes = 5).

Yes: Council Member - Kenneth Dick, Council Member - Steve Keegan, Council Member - Gary Smith, Council Member - G. Scott Black, Council Member - Jean Jackson.

Scott Black elected as Mayor of Clyde for 2016.

Mr. Selvey turned the meeting over to Mayor Black.

ELECTION OF VICE MAYOR

Mayor Black opened the floor for nominations for Vice Mayor.

Motion: to nominate Ken Dick for Vice Mayor for the year 2016, **Action:** Approve, **Moved by** Council Member - Steve Keegan, **Seconded by** Mayor – G. Scott Black. **Vote:** Motion carried by unanimous roll call vote (**summary:** Yes = 5).

Yes: Council Member - Steve Keegan, Council Member - Gary Smith, Council Member - G. Scott Black, Council Member - Jean Jackson, Council Member - Kenneth Dick.

Ken Dick elected as Vice Mayor of Clyde for 2016.

Mr. Selvey swore in the re-elected Mayor and elected Vice Mayor.


