**A RESOLUTION AWARDING A CONTRACT FOR THE CONSTRUCTION OF A STORAGE BUILDING FOR THE PARKS DEPARTMENT IN THE CITY OF CLYDE, OHIO TO CLASSICAL CONSTRUCTION LLC, APPLE CREEK, OHIO.**

**WHEREAS**, Clyde City Council on March 15, 2016 did pass Ordinance No. 2016-21, authorizing the bidding for the construction of a storage building for the Parks Department in the City of Clyde, Ohio, and

**WHEREAS**, said legal notice was advertised in a newspaper of general circulation, and

**WHEREAS**, bids were received and opened for said Parks Department Storage Building on May 16, 2016.

**NOW THEREFORE, BE IT RESOLVED**, by the Council of the City of Clyde, State of Ohio:

**SECTION 1.** That the Clyde City Council does hereby **award the bid for the construction of a storage building for the Parks Department to Classical Construction LLC, 8262 Secrest Road, Apple Creek, Ohio 44606 for the bid amount of One Hundred Sixty-Nine Thousand Nine Hundred Dollars and no cents (\$169,900.00).**

**SECTION 2.** That the City Manager is further authorized by this Council to execute any and all documents associated with this project, including Change Orders; Additional Work Orders by either Unit Pricing or agreed upon pricing by the City and the Contractor performing the work.

**SECTION 3.** That this Resolution shall take effect and be in full force immediately upon its passage.
