

ORDINANCE NO. 2016-35

AN ORDINANCE RENEWING SECTION 191 OF THE CODIFIED ORDINANCES OF THE CITY OF CLYDE WHICH LEVIES AN EXCISE TAX OF THREE PERCENT (3%) OF TRANSACTIONS BY WHICH LODGING BY A HOTEL/MOTEL IS OR IS TO BE FURNISHED TO TRANSIENT GUESTS PURSUANT TO OHIO REVISED CODE SECTION 5739.02(C)(1).

WHEREAS, City Council on August 7, 2001 passed Ordinance No. 2001-81 which established Section 191 of the Codified Ordinances of the City of Clyde, which levied an excise tax of three percent (3%) of transactions by which lodging by a hotel/motel is or is to be furnished to transient guests pursuant to Ohio Revised Code Section 5739.02(C)(1); and,

WHEREAS, in Section 3 of Ordinance No. 2001-81 the excise tax was imposed for a period of five (5) years from the effective date of that Ordinance which was September 7, 2001; and

WHEREAS, Ordinance No. 2006-74 passed July 18, 2006 extended the excise tax imposed by Ordinance No. 2001-81, as governed by Section 191 of the Codified Ordinances of the City of Clyde for another five (5) years that began September 7, 2006 and ended September 7, 2011; and

WHEREAS, Ordinance No. 2011-52 passed October 4, 2011 extended the excise tax imposed by Ordinance No. 2001-81, as governed by Section 191 of the Codified Ordinances of the City of Clyde for another five (5) years that began November 4, 2011 and ends November 4, 2016; and

WHEREAS, Council has determined that they wish to extend the imposition of the hotel/motel tax for another five (5) years.


NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Clyde, State of Ohio:

SECTION 1. That the excise tax imposed by Ordinance No. 2001-81, as governed by Section 191 of the Codified Ordinances of the City of Clyde is hereby extended for another five (5) years beginning November 5, 2016 and ending November 4, 2021

SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were passed in an open meeting of this Council, and that all such deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including the City's Charter and Codified Ordinances and Section 121.22 of the Revised Code of Ohio.

SECTION 3. This Ordinance shall take effect and be in force thirty (30) days after its passage.
